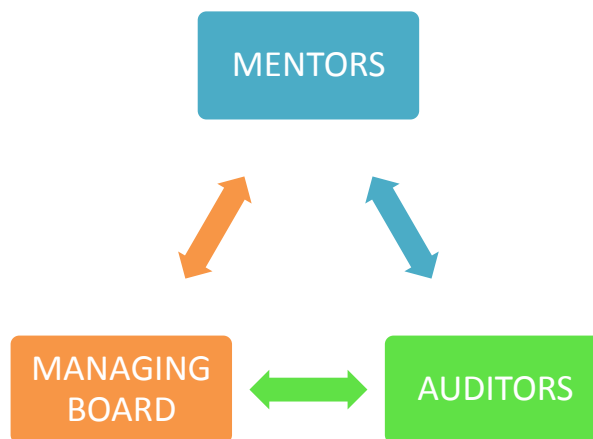

ROLE OF MENTORS

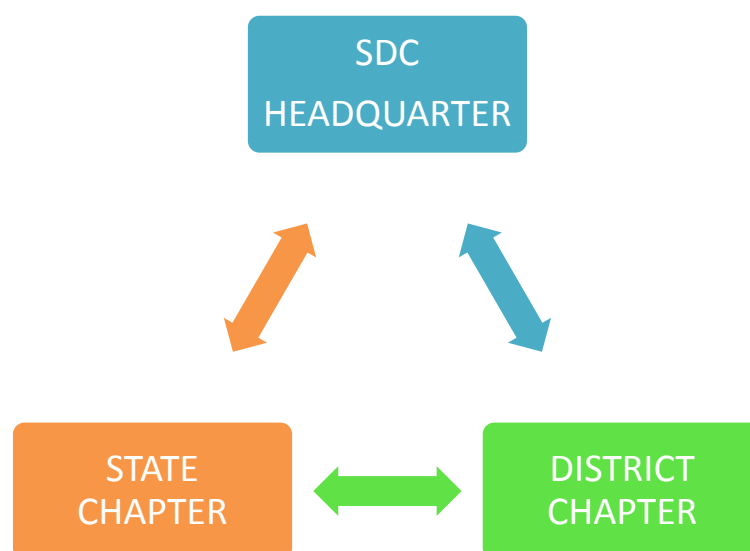

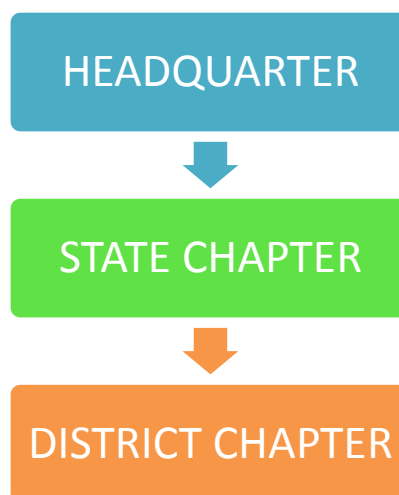
ROLE OF STATE CHAPTER
